## **NEW TRAINING FACILITIES**





In September, CISTC were proud to unveil 6 new state-of-the-art training rooms situated in a second training complex at our construction training centre in Farnham, Surrey.

The facilities were officially opened by Leo Docherty, Minister for Defence People and Veterans and Aldershot MP and CISTC's Managing Director John Whelan.

Leo Docherty has served as the Member of Parliament for Aldershot since 2017. He attended the Royal Military Academy Sandhurst and was commissioned into the Scots Guards in 2001. He then served in Iraq and Afghanistan with the 1st Battalion Scots Guards and 16 Air Assault Brigade. As Parliamentary Under Secretary of State (Minister for Defence People and Veterans) he is responsible for armed forces, veterans and civilian people policy.

After the opening and speeches, given by Mr Leo Docherty and Paddy Baines MBE, everyone enjoyed a light lunch. Leo was then given the opportunity to tour the rest of our training grounds and try his hand on one of our 360 excavators on our plant training field. Led by our expert trainer, Dimi Simicevas, he was able to see first-hand the quality of plant and training that we provide.







Following our recent signing of the Armed Forces Covenant, it is hugely important for us to demonstrate our respect and support for the Armed Forces Community. In recognition of this, we also invited some of our Natta personnel who are ex-military personnel to join us for the event.

# **EUSR (SHEA) DRAINS AND SEWERS**







#### **EUSR SHEA Drains and Sewers Passport**

This 1 day course is designed for individuals who work with drains and sewers and require access to operational sites within the drainage and sewerage industry, both permanent and temporary, at all levels including operatives, supervisors and management.

#### **Course Description**

This is a 1 day EUSR Safety Health and Environment Awareness (SHEA) Drains and Sewers Course.

The Utility Safety Health and Environment Awareness (SHEA) portfolio of schemes have been developed in conjunction with industry to provide a uniform approach to health, safety and environmental awareness training across the utilities sector, in line with Health and Safety Executive guidelines.

The programme content and scheme specification have been developed in collaboration with The National Association of Drainage Contractors (NADC). Programme material is produced and managed by Energy & Utility Skills on the drainage and sewerage industry's behalf. The content is reviewed periodically and consists of six core modules and two specific to the drainage and sewerage industry. All individuals will need to complete all eight modules and pass the SHEA Drains and Sewers assessment to receive the SHEA Drains and Sewers registration. The programme may only be delivered by trainers approved by Energy & Utility Skills.

The programme will be delivered through the context of the drainage and sewerage industry.

#### How do I get a EUSR Card?

Registration is based on the successful completion of a training programme and assessment. Following training the EUSR approved trainer will apply to register the trainee. EUSR cards are issued within 28 days of receipt of the necessary completed paperwork and payment. Operatives are issued with a cover note following training to confirm completion of the training and assessment while they wait for their card to be issued.

Registration and card supply costs are £30 + VAT.

#### **CSCS Affiliation**

The Utility SHEA (Drains and Sewers) scheme is affiliated with the CSCS to allow drainage and sewerage industry workers access to construction sites for purposes of utilities work without the need to complete a separate CSCS card.

#### Requirements:

A good level of written and spoken English is required to successfully complete this course. If you have any concerns regarding this please contact our office and we discuss available options (e.g. hiring a translator at an additional cost).

#### How is the course delivered / assessed:

This course comprises of a trainer lead presentation and assessment. Trainees will be called upon to share their experiences and thoughts throughout, to build on the course material.

#### What is awarded after completion of the course?:

Once the course has been completed candidates will receive a EUSR SHEA Drains and Sewers Passport.

#### When does the qualification expire?:

The EUSR Utility SHEA Drains and Sewers Passport Card is valid for 3 years from the date of training. After which the course will require renewal by anyone still working within the industry. Please note: the registration gained from the transition route will expire 3 years after the initial course.


